<p>A> HEI has provided screenshots of approved scholarships extracted from government portal, however, it has shown HEI's name nowhere. It appears that HEI has not applied institutional filter to extract the figures. Hence, change required.</p> <p>B> The HEI must provide screenshots of approved scholarships, extracted from the government portal after applying the appropriate filters—scheme wise and institution-wise filter. These should clearly indicate the students who benefited under each scheme, the scheme's name, and the name of the HEI.</p> <p>C> HEI is required to provide lists of students or beneficiaries, sourced from government portals such as the NIC portal or any authorized agency, pertaining to the schemes i. —Directorate of Technical Education, ii. —OBC, SEBC, VJNT & SBC Welfare Department, iii. —Social Justice and Special Assistance Department, and iv. —Tribal Development Department, for the academic year 2022-23 only, in PDF format. In these downloaded PDFs, the HEI must prominently highlight only those beneficiaries who have received payments or benefits, as indicated by statuses such as "SUCCESS," "SANCTIONED," or "DISBURSED." At present, the Data Verification and Validation (DVV) process finds no grounds to alter the reported figures, contingent upon further clarification from the HEI. However, adjustments may be made if additional clarification is provided.</p>	<p>This is to certify that, in Maharashtra State, students applying for the scholarship scheme through the Mahadbt-Portal (mahadbt.maharashtra.gov.in). The submitted data has been fetched from the institutional login portal which only shows the year-wise summary and list of the institutional applicants (Students). The filter was already applied while fetching the final data.</p> <p>Here the column “approved by the department”, means the scholarship application has been scrutinized by a Mahadbt officials, approved, and sent for final fund disbursement.</p> <p>HEI has considered only the students who applied, approved and fund-disbursed to the students by government.</p> <p>PDF download option is not available in Mahadbt, only Excel option is available.</p> <p>The links for the support documents for the assessment year is given in the preceding table for kind approval.</p>
