<p>A&gt; HEI has offered activities under two separate theme- i.e. i. Guidance for competitive examinations, and ii. Details of career counselling. However, some programs have been enlisted under two separate theme. Moreover, it has not furnished specifics regarding the duration or date of its undertaken initiatives, which ostensibly may have been organized as single day events. Furthermore, the events lasted only one day, including events on various topics such as —Guidance of Competitive Exam". Despite their general nature, DVV humbly contends that one- or two-day —EVENTS   fall under metric 3.2.2 and could potentially address emerging aspects of new professions. However, the current metric specifically calls for career counseling and guidance —PROGRAMS.   (Please note that the metric explicitly uses the term "program.") While events of such short duration offer certain benefits, they do not inherently meet the specific needs of exam preparation or career guidance, which require, at least, department-specific mentoring. Therefore, equating a one-day seminar to a program designed to focus solely on activities tailored to specific examinations or student groups is inappropriate and does a disservice to those who conduct such programs in that manner. Additionally, the attendance sheet lacks descriptions of the associated events. B&gt; HEI needs to provide the required documentation for verification as follows: 1. A digital copy of Circulars/Brochures/Reports delineating guidance programs for competitive examinations or career counseling. These materials should include detailed content/syllabi provided by HEI. 2. Geotagged photographs accompanied by descriptive captions from these programs, providing visual evidence of their occurrence and participation. 3. Comprehensive information regarding the personnel involved in each program, elucidating their roles and expertise.</p>	<p>This is to clarify that, students benefitted by guidance for competitive examinations and career counseling offered by the Institution during the last five years are only considered under this metric.
