<p>A>For conducting an FDP followings are essential: (i) Collaboration letter of recognized academic associations/academic bodies, academic/professional institutions, associations of business/industry, voluntary organizations, NGOs, and registered societies/trusts for the conduct of the FDP, which ensures the quality of an FDP. (ii) Coordinator must be a full time regular faculty with adequate experience in teaching and research with publications. It is evident from the number of publications HEI has claimed that, at least, the second criterion was not considered. Therefore, HEI needs to exclude the self organised FDPs.</p> <p>B> HEI needs to submit the revised data sheet in a tabular format. This table must be organized according to academic years and segmented into five distinct blocks, each representing one AY. Furthermore, each block should be arranged on a per-teacher/per non-teacher basis in the primary column, with subsequent columns delineating the programs attended by each respective individual.
